Instructions to Attorneys:

Contact any volunteer on the list to see if s/he is available to be appointed as the Holder of Education Rights for the specific minor who needs assistance. Once a volunteer agrees to accept the appointment, the court must limit the parents'/guardians' education rights, if the order has not already been made. The court, then appoints the volunteer Holder of Education Rights, noting the volunteer's information in the JV-535 form. The court sends a copy of the appointment order to the volunteer. The volunteer should keep a copy of the order and provide a copy to the principal of the minor's school.
